USDA BioPreferred[™] FAQ'S

What is the purpose of the BioPreferredsm program?

Managed by the U.S. Department of Agriculture, the BioPreferredsm procurement preference program was created to increase the purchase and use of biobased products by agencies of the federal government.

What makes a product "biobased?"

Section 9002 of the Farm Security and Rural Investment Act of 2002 defines a biobased product as a commercial or industrial product, other than food or feed, that contains, in whole or in significant part, renewable agricultural or forestry materials. This renewable content includes plant, animal and marine materials.


What is "biobased content?"

Biobased content is derived from renewable, biological sources, as opposed to non-renewable, fossil sources. The amount of biobased content in a given product is determined via ASTM Test Method D6866. This test compares the quantity of a decaying carbon isotope that remains in a sample to how much the same sample would contain if it were composed completely of recently grown materials. Results are expressed as percentages of biobased and fossil content. For example, refer to the pie chart depicting results for Kresto® Select.
